

Weighted Total Expense Ratio (WTER)

Included in the WTER is the proportion of costs that are incurred by the performance component, fee at benchmark, trading costs (including brokerage, VAT, STT, STRATE and insider trading levy) and other expenses. 




Asset class exposure (%)




