Taquanta Asset Management is our preferred investment manager mandated to achieve the above.

Portfolio commentary: Quarter 4

The AII Bond Index returned 3.78% (ZAR) over the quarter continuing its rally as S&P maintained South Africa's investment grade rating, ending the year up 15.45%. Property ended the quarter up 1.26% and the year 10.20% with cash ending the year up 7.39%. The Rand weakened marginally over the quarter but ended the year 12.36% higher vs the US Dollar. Expectations remain that the SARB will not be hiking rates given the low growth trajectory coupled with inflationary food price pressure.
