## Investment mandate and objective

The primary investment objective of the Fund is to generate real positive returns over time through the active management of a combination of money market, bond and income generating instruments. The strategy and investment mandate of the fund has a focus on income generation, with downside protection of capital.

## Investment features:

The Fund will primarily invest in a range of fixed income securities including instruments guaranteed by the Republic of South Africa, gilts, semi-gilts, Ioan stock, preference shares, debentures, debenture stock, debenture bonds, unsecured notes, financially sound listed property investments, participatory interest in collective investment schemes and any other instruments guaranteed by the Republic of South Africa which are considered consistent with the fund's primary objective. Taquanta Asset Management is our preferred investment manager mandated to achieve the above.

## Portfolio commentary: Quarter 1

The All Bond Index returned $2.46 \%$ (ZAR) over the quarter giving up a significant portion of intra quarter gains on the back of the political "Night of the long knives" as the 10 year yield pushed towards $8.86 \%$. Property ended the quarter up $1.37 \%$ falling in line with bonds at month end with cash ending the year up $1.84 \%$. The Rand gave up significant gains having reached 12.43 intra month before closing the quarter end at 13.41.
