#### Investment mandate and objective

The objective of the fund is to deliver market related performances over a rolling 5 year period. The fund is multi-managed to add diversification of investment strategies and sources of returns. The fund is allowed to invest across all local asset classes and to invest both locally and globally (as permitted by Regulation 28). The fund has specific manager allocations for capital growth through value investment managers. The managers' use stock selection and fair value to determine fund exposure. The managers prefer concentrated stock exposures, to maximize investment returns.




