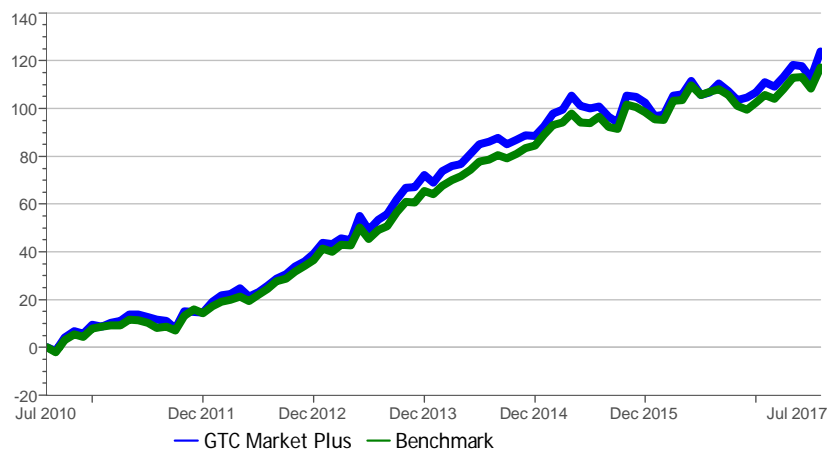

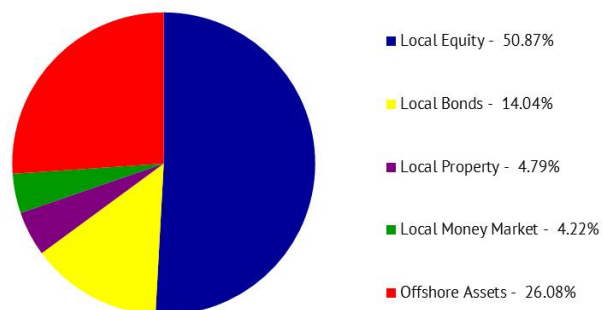

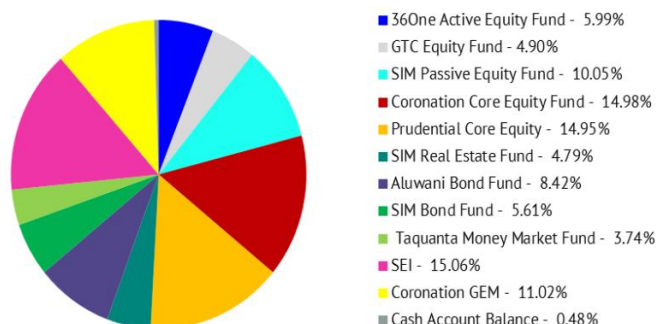

Investment manager weighting

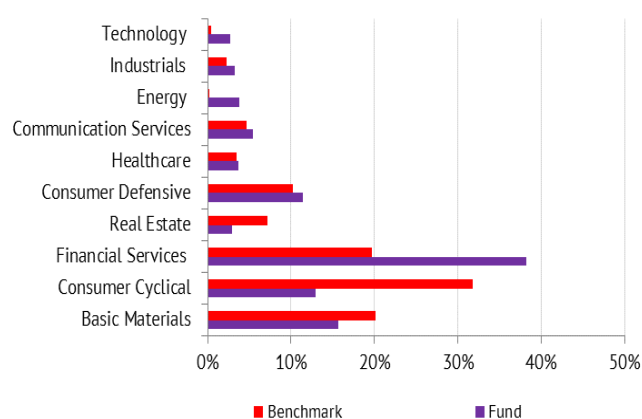
