The fund will primarily invest in a range of fixed income securities including instruments guaranteed by the Republic of South Africa, gilts, semi-gilts, loan stock, preference shares, debentures, debenture stock, debenture bonds, unsecured notes, financially sound listed property investments, participatory interest in collective investment schemes and any other instruments guaranteed by the Republic of South Africa which are considered consistent with the fund's primary objective. Taquanta Asset Management is our preferred investment manager mandated to achieve the above investment objectives.

Portfolio commentary: Quarter 3

Global markets continued their rally on the back of positive economic data from the US and Europe spurring a risk on environment shaking off the overhang of UK Brexit negotiations, posturing between Trump and his North Korean counterpart over nuclear capability, as well as natural disasters such as hurricanes battering the US.

Global bond markets as measured by the Citigroup WGBI was up 1.81% over the quarter despite a minor sell off in September as the Fed signalled its intentions on deleveraging its balance sheet and a rate hike in December despite inflationary concerns.

Locally the bond market rallied 3.68% amid strong buying particularly along the longer end of the yield curve (7+ years). The STEFI cash composite returned 1.85% over the quarter while the Rand closed at 13.50 to the US Dollar.
