



#### Portfolio commentary: Quarter 4

Locally the JSE had a very strong quarter printing an impressive 7.44% (ZAR) as results at the ANC elective conference in December was welcomed by market participants. Financials led the charge up 15.98% (ZAR) while Industrials (4.67%) and Resources (3.65%) also printing positive despite a selloff in December as rand hedge stocks weakened. Property ended up 4.21% as the All Bond Index returned a strong 5.66% with cash as measured by the STEFI composite returning 1.78% over the quarter. The Rand closed at 12.38 to the US Dollar strengthening by 9% from its O3 close of 13.50.
