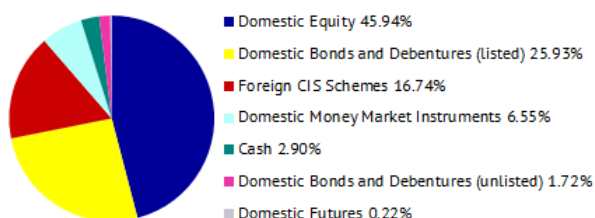

Asset class exposure



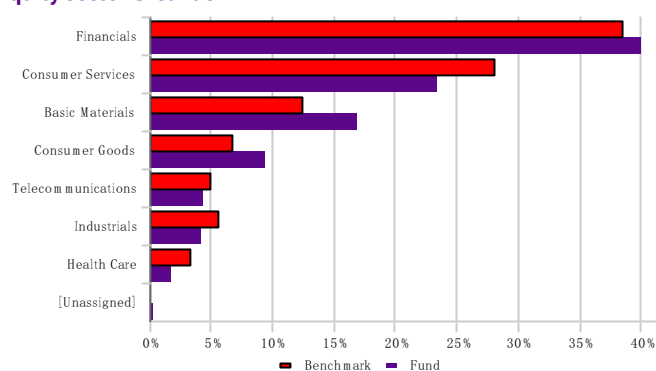
