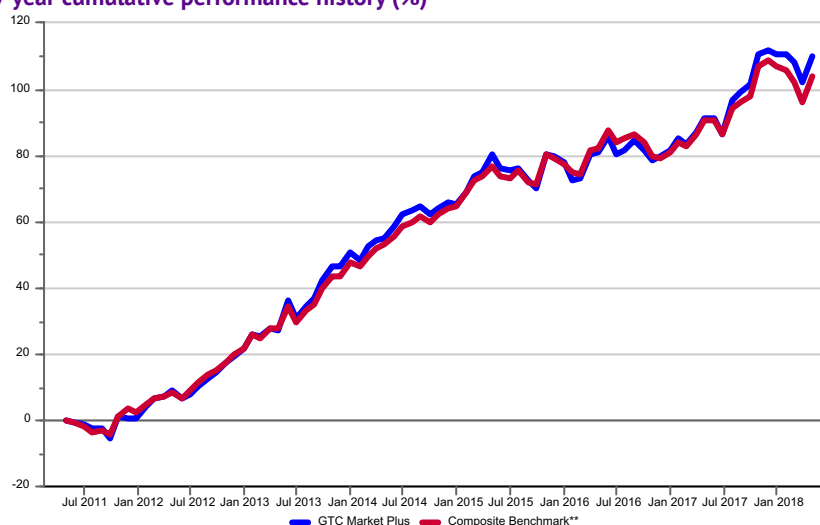

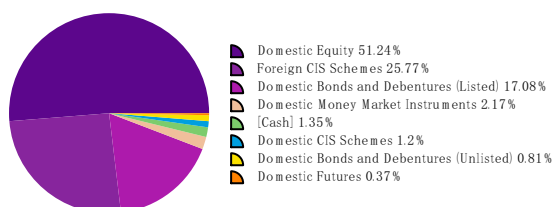

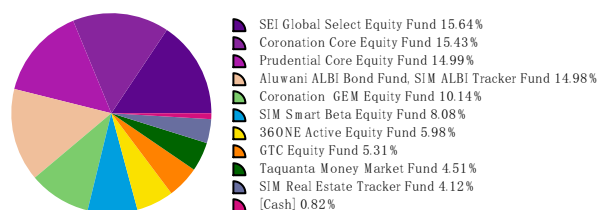

## Asset class exposure



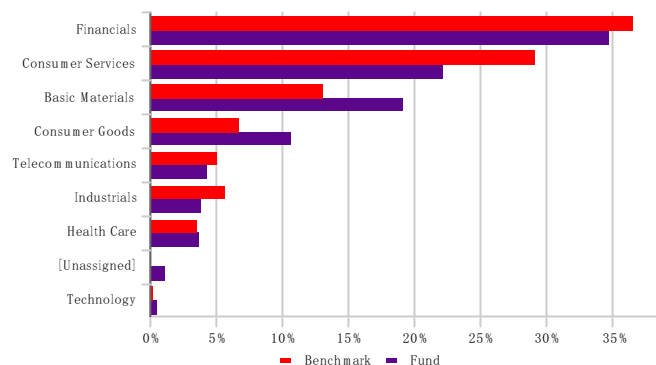
