### Investment mandate and objectives

The primary investment objective of the Fund is to generate real positive returns over time through the active management of a combination of money market, bond and income generating instruments. The strategy and investment mandate of the fund has a focus on income generation, with downside protection of capital.

**Features:** The fund will primarily invest in a range of fixed income securities including instruments guaranteed by the Republic of South Africa, gilts, semi-gilts, loan stock, preference shares, debentures, debenture stock, debenture bonds, unsecured notes, financially sound listed property investments, participatory interest in collective investment schemes and any other instruments guaranteed by the Republic of South Africa which are considered consistent with the fund's primary objective. Taquanta Asset Management is our preferred investment manager mandated to achieve the above investment objectives.

### Quarterly commentary

Global bond markets posted 0.85% (USD) over the quarter as investors sought the security of safe havens in the uncertain environment despite the US Fed cutting rates and the ECB advising of a stimulus package which included the lowering of a key interest rate as well as EUR20bn worth of monthly bond purchases.

As widely expected, the SA Reserve Bank kept its rates unchanged despite a flagging economy and a lower than expected inflation print in July. Expectations are that the central bank will follow global peers in cutting rates at its November meeting. The All Bond Index ended up 0.74% while its inflation linked counterpart ended up 0.12% over the quarter. Property followed the decline in EM growth assets, falling -4.44% while cash returned 1.79%. The Rand weakened closing at R15.16 to the US dollar.

This portfolio has a low risk profile. It is suitable for low to medium term investment horizons. It has an exposure to a combination of money market, bonds and income generating instruments. Definition of the terms used to measure the risk in the portfolios a) Tracking Error: tracking error or active risk is a measure of the risk in an investment portfolio that is due to active management decisions made by the portfolio manager; it indicates how closely a portfolio follows the index to which it is benchmarked and b) Standard deviation: is a measure that is used to quantify the amount of variation or dispersion of a set of data values around the mean value. This measure is commonly known as volatility and referenced as an explicit measure of risk. One can also obtain additional information on GTC products on the website and all price related queries or information is readily available on request. Fund of funds are portfolios that invests in portfolios of collective investment schemes that levy their own charges, which could result in a higher fee structure for the fund of funds. The daily cut off time is 14:00 for trades and the valuation point is 17:00. Prices are published on Finswitch by 10:00 daily.
