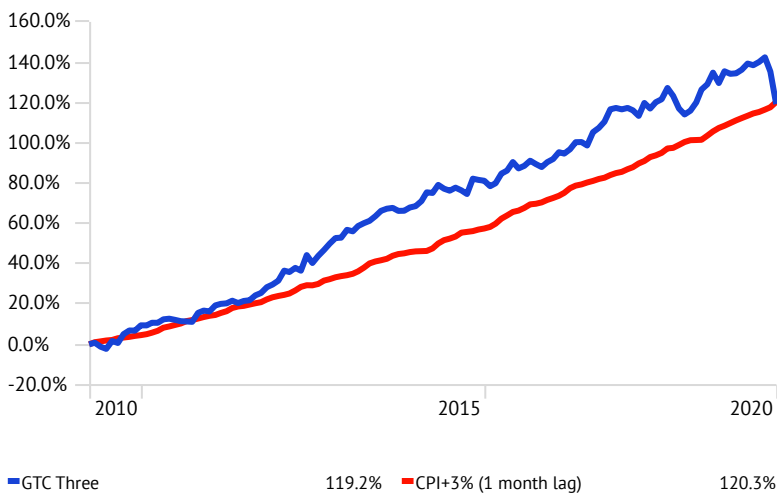
## Investment mandate and objectives

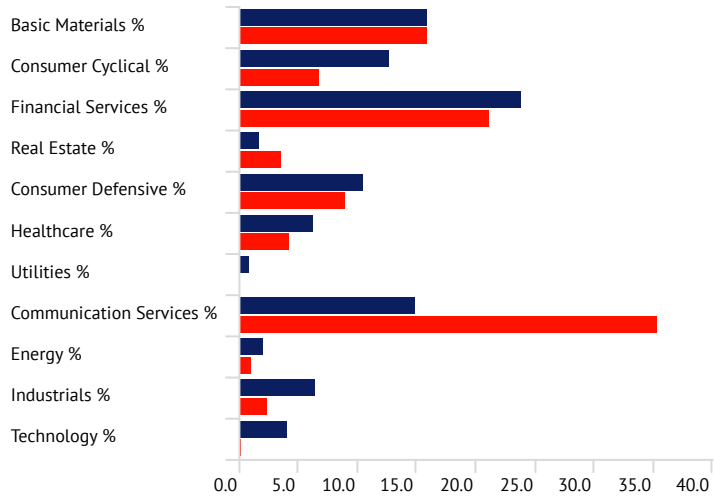
