Features: The fund will primarily invest in a range of fixed income securities including instruments guaranteed by the Republic of South Africa, gilts, semi-gilts, loan stock, preference shares, debentures, debenture stock, debenture bonds, unsecured notes, financially sound listed property investments, participatory interest in collective investment schemes and any other instruments guaranteed by the Republic of South Africa which are considered consistent with the fund's primary objective. Taquanta Asset Management is our preferred investment manager mandated to achieve the above investment objectives.

Quarterly commentary

Following from the impact of the Corona virus crisis, most central banks across the world cut interest rates in their stimulus efforts to reduce the negative impact the outbreak is having on their economy. Global bonds ended the quarter up 2% with the rand weakening 21.7% to the dollar. Over the quarter the South African Reserve Bank cut interest rates by 1% as part of its monetary stimulus policy with further rate cuts to follow should the situation continue to deteriorate. Moody's announced the downgrade of SA's sovereign rating to junk status from Baa3 to Ba1 and has maintained its negative outlook to reflect downside risks to SA's growth and fiscal metrics. The rating agency expects growth in economic activity to decline by -2.5% in 2020 before recovering to 1.1% in 2021. The JSE All Bond Index ended the quarter down 8.7%.

This measure is commonly known as volatility and referenced as an explicit measure of risk. Fund of funds are portfolios that invests in portfolios of collective investment schemes that levy their own charges, which could result in a higher fee structure for the fund of funds.
